

# **COVID-19 concerns notice and exemption**

# Public Health (COVID-19 Interstate Travellers) Order 2021

Made under the Public Health Act 2010 (NSW)

- I, Dr Stephen Conaty, Deputy Public Health Controller and delegate of the Chief Health Officer, NSW Ministry of Health, under clause 5(1) of the *Public Health (COVID-19 Interstate Travellers) Order 2021* (the Order) and section 43 of the *Interpretation Act 1987*, hereby:
  - 1. Revoke all previous COVID-19 concerns notices.

### **AFFECTED AREAS**

2. Identify, in the table below, the following area as an *affected area* for the purposes of clause 5 of the Order and specify the relevant points of entry to New South Wales for the affected area.

### Note:

 If a person 16 years of age or over has been in an affected area within the previous 14 days, on arrival in NSW at a relevant entry point they must substantially complete a traveller self-declaration either 24 hours prior to entry into NSW, or on entering NSW

3. Identify the following areas as a place of concern, for the purposes of clauses 3 and 5 of the Order:

### Places of concern

The following Western Australian local government areas:

# Perth Metropolitan Area

The local government areas of Armadale, Bassendean, Bayswater, Belmont, Cambridge, Canning, Claremont, Cockburn, Cottesloe, East Fremantle, Fremantle, Gosnells, Joondalup, Kalamunda, Kwinana, Mandurah, Melville, Mosman Park, Mundaring, Nedlands, Peppermint Grove, Perth, Rockingham, Serpentine-Jarrahdale, South Perth, Stirling, Subiaco, Swan, Victoria Park, Vincent and Wanneroo, and the western part of the Shire of Murray.

## Peel region

The five local government areas of Boddington, Murray, Serpentine-Jarrahdale, Waroona shires and the City of Mandurah

on or after 12.01 am on 24 April 2021

Note: A person who has been in a place of concern on or after the time specified above must, after arriving in NSW, immediately travel directly to the person's place of residence or a suitable place to reside in. If already in NSW, the person must immediately return to their place of residence or other suitable place. The person must not leave that residence except with a reasonable excuse for 14 days after they were last in a place of concern or while this notice is in force, whichever is sooner.

Note: This obligation does not apply to a person who enters, or has entered, New South Wales for immediate travel by the most direct practicable route to a place outside New South Wales.

Note: A person, who is not a NSW resident, who has been in a place of high concern, during the period specified for that place, must not enter NSW.

A person in NSW who has been in a place of high concern during the time specified for that place:

- is a close contact of a person diagnosed with COVID-19, and
- must, if arriving in NSW, comply with the Interstate Traveller Guidelines, and
- must self-isolate as required by the Public Health (COVID-19 Self-Isolation) Order 2021 as if the person had been directed to do so in writing by or on behalf of an authorised contact tracer.

# Exemption in relation to places of high concern

- 5. As delegate of the Minister for Health and Medical Research, in accordance with clause 15 of the Order, grant the following exemption to the Order:
  - a. A person who has been to a Category B place of high concern is exempt from clause 12 of the Order (the directions in relation to persons who have been in a place of high concern) but only if the person:

- i. has not been to a Category A place of high concern, and
- ii. has undergone a test for COVID-19 after the person was at the Category B place of high concern, and received a negative result, and
- iii. has retained the notification for that negative test result.

Note: a person who is exempted from clause 12 of the Order is still be required to comply with the remainder of the Order.
