Power to appoint persons as inspectors for the purposes of the Public Health (Tobacco) Act 2008.

Conditions

1. An inspector who is not a police officer must be issued with a certificate of authority.
 2. The certificate of authority must –
 - (a) be in the form approved by the delegate; and
 - (b) contain a recent photograph of the inspector.
