HEALTH AND MEDICAL PLANS FOR MUSIC FESTIVALS**Authority to:**

- a) provide advice to the Secretary, Department of Creative Industries, Tourism, Hospitality and Sport for the purpose of section 5(2)(a) of the Music Festivals Act 2019;
 - b) specify a day, being later than the prescribed day, on which a music festival organiser must give a health and medical plan to the Health Secretary;
 - c) decide to agree (with or without changes) or refuse to agree to a health and medical plan; and
 - d) specify the day, being later than the prescribed day, for which a decision to agree or refuse to agree to a health and medical plan must be made by.
